An extraordinary general meeting held on 28 March 2013 have approved (1) the maturity date of the outstanding Convertible Note with principal amount of HK\$28,080,000 has been extended for one year until 28 March 2014; (2) the Convertible Note bear interest on the outstanding principal amount at the rate of 2% per annum; (3) the Conversion Price will be changed to HK\$0.5 for each Conversion Shares; and (4) the maximum Conversion Shares can be allotted and issued under the Specific Mandate upon exercise of the conversion right has changed to 56,160,000 Conversion Shares subject to the conversion restriction and public float restriction. All of the above changes have been effective from 28 March 2013. Details have been disclosed on the announcement dated 28 March 2013.
