EXTENSION OF LONG STOP DATE AND FURTHER DELAY IN DESPATCH OF CIRCULAR

Reference is made to the announcement of Evershine Group Holdings Limited (the “**Company**”) dated 24 March 2016 in relation to, among other things, the acquisition of the Target Companies and the announcements of the Company dated 19 April 2016 and 6 May 2016 in relation to the delay in despatch of circular (collectively the “**Announcements**”). Unless the context otherwise requires, terms used in this announcement have the same meanings as defined in the Announcements.

EXTENSION OF LONG STOP DATE

In order to allow the parties to the Acquisition Agreements more time to satisfy certain conditions precedent contained therein and pursuant to the Acquisition Agreements, the parties to the Acquisition Agreement have entered into side letters (“**Side Letters**”) on 19 May 2016, pursuant to which they have agreed to extend the long stop date for completion of the Acquisition Agreements to 30 June 2016 (or such other date as may be agreed between the parties thereto in writing from time to time). Save for the amendment under the Side Letters as described above, all other terms and conditions of the Acquisition Agreements remain unchanged.

FURTHER DELAY IN DESPATCH OF CIRCULAR

As stated in the Announcements, the Circular containing, amongst others, further details about the Proposed Acquisition and the notice convening the EGM, will be despatched to the Shareholders on or before 20 May 2016. As additional time is required to finalise certain information to be included in the circular, it is expected that the despatch date of the circular will be postponed to a date on or before 24 May 2016.
